### Plan of Correction

1. **POC:** Licensing official observed pea gravel sitting outside of playground area. The owner informed the licensing official the pea gravel will be added to the playground area once the other owner is able to return to the facility due to medical reasons. At least 9 inches of pea gravel will be needed for adequate surfacing (Appendix D, page 11) Licensing official observed damaged playground equipment. Per the owner, the facility observed squirrels gnawing on playground equipment which caused the damages. The owner stated


