### Playground Violations Cited

1. **Out of Compliance:** Playground area is clean and free of hazards. (Rule 1.11.11 Page 61)
2. **Out of Compliance:** All toys and equipment is in good repair (i.e., not broken or deteriorating). (Rule 1.10.2(2) Page 46)
3. **Out of Compliance:** If swings are present, S hooks are in good repair and closed (i.e., no gap greater than 0.04 inches or thickness of a dime). (CPSC 3.2 Page 14)

#### Plan of Correction

1. **POC:** The frame of the swing set is beginning to sag and show signs of deterioration thus creating a hazard. Due to swing chains and saddles (seats) being tied and twisted, this creates a potential entrapment hazard. Facility has 60 days to remove swingset. The mulch, swings and spring rockers must be removed within 60 days. Failure to do so will result in critical playground violations. Critical violations will result in a failed inspection and the facility will not be able to operate.

**Person Responsible:** Wendy Williford **Date for Completion:** 60 Days

2. **POC:** The surfacing around the swings and spring rockers is inadequate. The mulch has composted down to the point it posing a tripping hazard. Existing mulch must be removed within 60 days. The mulch, swings and spring rockers must be removed within 60 days. Failure to do so will result in critical playground violations. Critical violations will result in a failed inspection and the facility will not be able to operate.

**Person Responsible:** Wendy Williford **Date for Completion:** 60 Days

3. **POC:** Spring Rockers are in poor repair with inadequate surfacing around the rockers. The surfacing around the rockers is too deep and prevents the equipment being used for it's intended purpose. The fall zone around some of the rockers appears to less than 6 feet. Facility has 60 days to remove the spring rockers. The mulch, swings and spring rockers must be removed within 60 days. Failure to do so will result in critical playground violations. Critical violations will result in a failed inspection and the facility will not be able to operate.
