1. **Out of Compliance:** Playground fence is less than 3 ½ inches from ground surface, in good repair with no gaps and secure gate latch. (Rule 1.11.9(8) Page 60)
2. **Out of Compliance:** The outdoor playground is free of hazards and not less than 30 feet (measured horizontally parallel to the ground) from electrical transformers, high voltage cabling/wires, electrical substations, railroad tracks, or sources of toxic fumes or gases. Hazards including but not limited to air conditioner units and utility mains, meters, tanks, and/or cabling are inaccessible. (Rule 1.11.9(5) Page 59)
3. **Out of Compliance:** All bolts on equipment and fences are no more than two threads beyond the nut. (Rule 1.11.9 Page 59)
4. **Out of Compliance:** All bolts and fencing twists and wires are facing away from the playground area. (Rule 1.11.9 Page 59)
5. **Out of Compliance:** Playground area is clean and free of hazards. (Rule 1.11.11 Page 61)
6. **Out of Compliance:** All toys and equipment is in good repair (i.e., not broken or deteriorating). (Rule 1.10.2(2) Page 46)

Plan of Correction

1. **POC:** on playground, one where poor in place is the facility will remove the barrier of milk crates and either install a new fence there and the facility will need to be re-measured on that playground for capacity of playground at the facility. Doesn't want to put up of barrier there they were clean up the back part of the playground and have it accessible to children and remove the crates from the playground. this playground also has a few faces on the fencing at the bottom where they would has been removed and the wire is available for kids to be able to touch the facility will install new boards to hold down the fencing that is a long the rest of the fence. The facility will have all the bolts cut on playground. I know that fence was installed around March 2023. The facility had not been rechecked on playground after new fencing was installed. The facility will have two weeks on July 14, 2023 at the playground is not finished. The facility will email the licensing official asking for an extension and the reasons why. The playground that has concrete area will be out of service until further notice. If the facility chooses not to use this area for a permanent, it will be taken off of there space for capacity for playground if the facility uses the space, they will remove the objects that are broken and send lysing a picture of a picture of updates.
