3. **Out of Compliance:** Appropriate surfacing material is present and meets minimum required compressed loose-fill surfacing depths (e.g., 6 inches for shredded/recycled rubber; 9 inches for sand, pea gravel, wood

1. **POC:** Facility has already informed the licensing official of new playground surfacing that would be taken placed. Pictures and an detail email examining how the work would take place-per playground. Wren Construction is doing the work to the playground. Director and Designees stated that the younger children are using the toddlers playground which is not under construction at the time. Older children use the grassy area which corns are-placed to block off area and the front area of the facility. licensing will conduct a follow-up visit once completed. The director-designees will follow-up with the licensing official once completed.
