It was also explained that until these pipes are covered highlighter paint should be sprayed around them to prevent a hazard on the play area. This should be completed by the timeframe given.

Per the director, this will be added by Jan 3, 2023 due to the upcoming holidays. A recommendation was given on placing the two year olds that are in pull-ups in the preschool classroom and placing a diaper changing table by the sink in this classroom to be in compliance.
