2. **Out of Compliance:** Tree limbs and other suspended hazards at least seven feet above play surfaces. Fence is free of brush and overgrowth. (CPSC 3.5 Page 16)

#### Plan of Correction

1. **POC:** The licensing official observed overgrowth of brush on playground fences and the tree limbs overhanging the playground area. The brush should be removed from the playground fences and the tree limbs should be cut back at least 7 feet above the playground area before the licensure period expires 10/31/2022.
