Plan of Correction

1. **POC:** During review of records, CCFI observed four caregivers that need a letter of suitability. One caregiver has been fingerprinted, but prints were not clear. Per Director, all four have appointments to get fingerprint scans done tomorrow. Facility will send letters of suitability of the four caregivers once received. Director and caregivers understand that they cannot be left alone with children until a letter of suitability is on file at the facility.

2. **POC:** During review of records, CCFI observed one child that needs an updated 121. The facility will have updated 121 on file at the facility by March 29th. Once received, copy will be sent to CCFI. If there is not an updated 121 on file at the facility by March 29th, the child cannot return until there is.
