<u>Infant Classroom - Classroom Number: 1</u>

1. **POC:** Based on observations while touring the facility, the facility failed to maintain the minimum staff-to-child ratio in room #1 (infant classroom), there were 2 caregiver to 11 children, the youngest was an infant. Per regulations the minimum staff-to-child ratio for infant is one staff to 5 children. This resulted in the facility being over ratio by 1 child. Technical assistance was given to Lillie Hoskins on ensuring that staff-

to-child ratio is met at all time. Due to low staffing, this could not be corrected during inspection.. Per Lillie Hoskins she will move two older children to building # 2 on November 17, 2021.

<u>Toddler Classroom - Classroom Number: 2</u>

1. **POC:** Based on observations while touring the facility, the facility failed to maintain the minimum staff-to-child ratio in room #2 (toddler classroom), there was 1 caregiver to 10 children, the youngest was one year old. Per regulations the minimum staff-to-child ratio for 1 one year old is one staff to 9 children. This resulted in the facility being over ratio by 1 child. Technical assistance was given to Lillie Hoskins on ensuring that staff-to-child ratio is met at all time. Due to low staffing, this could not be corrected during inspection. Per Lillie Hoskins she will move two older children to building # 2 on November 17, 2021.
