Per Mrs. Sprouse she will conduct (5) in-house hours herself with her staff.TA: Technical assistance was provided on Rule 1.5.8(2) Staff DevelopmentSubchapter 25: Hearings, Emergency Suspensions, Legal Actions and PenaltiesDeficiency: Rule 1.25.9(21) Failure to have proper (up-to-date) immigration documentation in each child's record.Findings: The licensing official observed during the program review children's record check that (4) children's MSDH 121 forms had expired and (1) child did not have a MSDH 121 form on file.POC: Per director, Loretta Sprouse, she will be responsible for contacting parents for an valid MSDH 121 form for (5) children. 
