1. **Out of Compliance:** Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towels for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)

Plan of Correction

1. **POC:** During walkthrough of facility, CCFI observed two toilets that are not in working order. Owner stated that she is getting the new "guts" for the toilet today. The toilets must be fixed by August 16th CCFI will return for follow-up to check the toilets. If toilets are not fixed, this could decrease the facility's capacity

1. **Out of Compliance:** Appropriate surfacing material is present and meets minimum required compressed loose-fill surfacing depths (e.g., 6 inches for shredded/recycled rubber; 9 inches for sand, pea gravel, wood mulch (non-CCA), and woodchips). (Appendix D 2.4 & 2.5 Page 8-10)

Plan of Correction

1. **POC:** During walkthrough of facility, CCFI observed two pieces of equipment on the playground that need surfacing. There is a piece of slide equipment and a jeep that is on springs Both of these must have surfacing 6 feet around. This was discussed with Owner Owner stated that this will be done in the next two week. CCFI will return for follow-up on this.
