1. **Out of Compliance:** All vehicles have current licenses and registrations. (Rule 1.15.2 Page 75)

1. **POC:** Transportation; LO observe one of the vans tag is expired. Director stated that she was unaware of tag being out and will get tag today 8/11/21. Director will send LO a picture of tag once purchased.

1. **Out of Compliance:** A Certified Food Manager or designated person in charge is present who can demonstrate knowledge and perform duties. (FC 2-101.11, 2-102.11, & 2-103.1)

Plan of Correction

1. **POC:** Food Manager; Director stated that she took the tummy-safe in June and said she received an email stating that she passed the exam, but when email was searched while LO was present no email was found. Director called MS State extension while LO was present to see if she could get proctor to email the passing score again and the proctor was not available to talk due to administering a test. Director gave contact information the the receptionist to call back. LO stated to the director that an email must be sent with passing score or certificate must be sent by August 27, 2021. Completion Date; 8/27/21 Upon exit conference with director, Dr. Ware from Tummy safe returned the call and LO did hear her say she passed the test. LO also witness that director made a 93% on test and a email was sent. LO asked director to forward email to LO email. LO witness message sent but LO haven't received email.
